Socorro Transportation operations are funded primarily by a 5311 grant awarded by the Department of Transportation Transit and Rail Division, together with general revenue funds from the City of Socorro and passenger fare revenues.

Organizational Success

Small city and rural areas have public transportation needs that are just as compelling as those in big cities. Socorro Transportation has been a great success in the City of Socorro. Aging populations, young people, disabled citizens, & working families are being served within the city limits. Socorro Transportation has been addressing the needs in the City of Socorro and Socorro County, as well as, the needs of commuters traveling Northbound and Southbound to and from Santa Fe, Bernalillo and Valencia Counties by connecting with the Rail Runner in Belen, New Mexico. We have addressed the needs of people using the Rail Runner with established routes to the Station in Belen. We continue to include a Sunday Shuttle to return local citizens and college students back home or to school after a weekend trip to Albuquerque or Santa Fe, or those returning by air flying into the Albuquerque Airport.

We also continue our route to the Central New Mexico Dialysis Kidney Center, addressing the needs of people who are in need of dialysis but cannot afford the day to day expense of traveling.

In April 2012, Socorro Transportation received the award for Section 5311 Rural Transit of the Year from the New Mexico Department of Transportation Transit and Rail

Highlights

August 2006

South Central Council of Governments (SCCOG) transferred the funds and operations of the Section 5311 Project FY-2005-2006 to the City of Socorro. The SCCOG also transferred a 2002 Econo van so the City of Socorro could continue a JARC route that ended recently in the area. Service was:

February 2007

Purchased a 12 passenger bus with wheel chair accessibility. Plans include to establish a route to include transportation to the Valencia Campus and consider a route to include the Rail Runner in Belen. A full time driver was hired.

February 2008

Purchased a 14 passenger bus.

April 2009

Purchased a 13 passenger bus.

Hired a part time driver

May 2010

Purchased a 6 passenger minivan with wheelchair accessibility

October 2010

Purchased a 12 passenger bus with 2 wheelchair positions.

April 2011

Hired 1 part time driver and 1 full time driver

April 2012

Received 5311 Rural Transit System of the Year

May 2012

Purchased a 20 passenger CNG (Compressed Natural Gas) bus

February 2013

Purchased a 11 passenger CNG (Compressed Natural Gas) bus with wheel chair accessibility

April 2013

Started a route for Dialysis patients to get to the Clinic in Los Lunas, New Mexico. Fare is \$5.00

July 2013

Hired a part time driver

June 2014

Fare Increase

Rail Runner - Increase from \$2.00 to \$2.25

Magdalena/Alamo Route – Increase from \$1.00 to \$1.25

April 2014

5304 Planning funds awarded from NMDOT in the amount of \$16,000.00 to complete a Transit Service plan for a Feasibility Plan for a Fixed Route.

March 2015

Fixed Route Transit Final Report prepared for the City of Socorro by KFH Group, Inc.

May 2016

Purchased a 6 passenger Mini Van

Purchased a 12 passenger CNG bus (ordered in March 2016)

Purchased a 16 passenger CNG bus (ordered in February 2016)

October 2016

Received funding for a CNG fueling station which is currently under construction
