Sealed Bids for the construction of the Water Reclamation Facility Improvements , IFB No. 092220a, will be received by the City of Socorro at the City Hall, 111 School of Mines Road , Socorro, NM 87801, until 10:00 a.m. local time on September 22, 2020, at which time the Bids received will be publicly opened and read.

Improvements to the City of Socorro Water Reclamation Facility to include removal of three (3) SBR Blowers and 12-inch ductile iron SBR header piping, including fittings, butterfly valves, etc.; installation of three (3) new SBR Blowers, including VFD's, electrical and controls, DO control, including transducers, wire and conduit, new 12-inch welded steel header piping, including fittings and new manual and motor actuated butterfly valves ; structural improvements to the existing SBR, Digester and Thickener basins, including SBR Basin #1 North Wall Stabilization, severe crack repair, minor crack repair, etc.; and other incidental work identified in a base bid schedule and two additive bid schedules, to complete a project within the available funding.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form. The Owner reserves the right to adjust quantities included in the Bid Schedule as necessary to provide a complete project with the available funding.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of \$200.00 for each set. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "DENNIS ENGINEERING COMPANY". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The

date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A pre-bid conference will be held at 10:00 a.m. local time on September 3, 2020 at the City Hall located at 111 School of Mines Road, Socorro, NM 87801 and via **GoToMeeting Web Conferencing**. Representatives of the Owner and Engineer will be present to discuss the Project. Bidders are **REQUIRED** to attend and participate in the conference. Failure to attend the pre-bid conference by a Bidder will result in the rejection of their Bid. Bidders shall provide their contact information when obtaining bidding documents from the Engineer or submit interest in attending the Web Conference to the Engineer a minimum of 24-hours in advance of the Pre-Bid Conference.

Bid security shall be furnished in accordance with the Instructions to Bidders.

Section 746 of Title VII of the Consolidated Appropriations Act of 2017 (Division A – Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2017) and subsequent statutes mandating domestic preference applies an American Iron and Steel requirement to this project. All listed iron and steel products used in this project must be produced in the United States. The term “iron and steel products” means the following products made primarily of iron or steel: lined or unlined pipes and fittings, manhole covers and other municipal castings, hydrants, tanks, flanges, pipe clamps and restraints, valves, structural steel, reinforced precast concrete, and construction materials. The de minimis and minor components waiver apply to this contract.
