# **SCOPE OF WORK**

The City of Socorro is requesting qualifications from Engineering firms to design the Sedillo Park Renovation.

- New LED lighting
- Quality Bleachers
- Secured playground
- New/remodeled concession/press box
- Water Plaza
- Upgrade and improve the Tennis & Pickle Ball Courts
- Upgrade and cover the Swimming Pool
- Upgrade and improve the picnic areas
- Design new parking
- Trash barrier on south side of tennis courts and swimming pool
- Other recommendations by Designer

## CONTENTS OF STATEMENT OF QUALIFICATIONS

- 1. Proposers interested in the provision of Engineering services to accomplish the proposed project should limit their Statements of Qualifications to ten (10) pages, exclusive of cover letters, divider tabs or letters of transmittal containing introductory language only. The Statement of Qualifications should include:
  - a. A cover letter.

- b. A narrative statement detailing the Proposer's understanding of the requirements of the City and the capability to perform the aspects of the Engineering Services.
- c. A general description of the Proposer's firm, including company organizational structure, size of company, recent experience in comparable projects.
- d. Identification of those key individuals who will be involved in the contemplated projects and their qualifications, backgrounds, experience, and specific responsibilities.

# **PROCUREMENT**

The City of Socorro is seeking qualified Engineers for the design of the Sedillo Park Renovation.

Interested firms shall submit one (1) original and four (4) copies of the information on or before 11:00 a.m., December 15, 2023, at 111 School of Mines Road, Socorro, New Mexico 87801.

The following information shall be provided on the front lower left corner of the envelope: Project Title: Engineering Services – Sedillo Park Renovations, RFQ No. 121523. If the Proposal is sent by mail, the sealed envelope shall have the notation "SEALED PROPOSAL ENCLOSED" on the face thereof. The proposer shall assume full responsibility for the timely delivery of the Proposal.

## **SELECTION PROCESS**

From a review of the statements of qualification received, the City of Socorro intends to evaluate the proposals and possibly invite one or more firms to be interviewed before making a final selection of a firm for the project. The City of Socorro will notify selected firms of the date and times of any interview. The City of Socorro reserves the right to make a selection based solely on statements of qualifications received.

The selected respondent whose selection was based on qualifications will then negotiate with the City of Socorro on a fee and contract conditions. If a reasonable fee cannot be achieved with the respondent of choice, negotiations will proceed with other qualified respondents until a mutually agreed contract can be negotiated.

# **SELECTION CRITERIA**

Selection criteria will be applied in the following order of importance:

# 1. **Qualifications of Firm**

Qualifications of firm, specifically as they relate to this project.

# 2. Firms Experience on Similar Projects

Related project experience of the firm and the individuals who would be assigned to the project.

# 3. Available Resources to Complete Project

This criterion would include the analytical, design tools, personnel, resources, or methodologies commonly used by the firm that may be applicable to the project categories.
